## TERMS & CONDITIONS OF SERVICE

### 1. Definitions:

- (a) "Addressable System" means an electronic device or more than one electronic devices put in an integrated system through which signals of television channels can be sent in encrypted form, which can be decoded by the device or devices at the premises of the subscriber within limits of the authorization made, through the Conditional Access System and Subscriber Management System on the explicit choice and request of such subscriber, by the cable operator to the subscriber.
- (b) "Alternative Tariff Package" (ATP) means a tariff package which a service provider may offer, in addition to the standard tariff package, for supply of a set box to the subscriber for receiving programmes;
- (c) "Authority" means Telecom Regulatory Authority of India established under sub-section (1) of section 3 of the Telecom Regulatory, Authority of India Act, 1997 (24 of 1997);
- (d) "Authorized Officer" shall have the same meaning as given in clause (a) of section 2 of the Cable Television Networks (Regulation) Act, 1995 (7 of 1995);
- (e) "Broadcaster" means any person including an individual, group of persons, public or body corporate, firm or any organization or body who or which is providing programming services and includes his or her authorized distribution agencies;
- (f) "Basic Service Tier" means a package of free-to-air channels offered by the cable operator to a subscriber with an option to subscribe, for a single price to the subscribers of the area in which his cable television networks is providing service;
- (g) "DAS Area" means the area notified under sub-section (1) of the section 4A of the Cable Television Networks (Regulation) Act, 1995 (7 of 1995);
- (h) "LCO" means a Local Cable Operator i.e. person who provides cable service through a cable television network or otherwise controls or is responsible for the management and operation of a cable television network;
- (i) "Cable Service" means the transmission by cables of programmes including retransmission by cables of any broadcast television signals;
- (j) "Cable Television Network" means any system consisting of closed transmission paths and associated signal generation, control and distribution equipment, designed to provide cable service for reception by multiple subscribers;
- (k) "Free to Air Channel" or "FTA channel" means a channel for which no fees is to be paid to the broadcaster for its retransmission through electromagnetic waves through cable or through space intended to be received by the general public either directly or indirectly;
- (l) "Multi System Operator" (MSO) means a cable operator who receives a programming service from a broadcaster or his authorized agencies and retransmits the same or transmits his own programming service for simultaneous reception either by multiple subscribers directly or through one or more cable operators, and includes authorized distribution agencies by whatever name called;
- (m) "Pay Channel" means a channel for which fees is to be paid to the broadcaster for its retransmission through electromagnetic waves through cable or through space intended to be received by the general public either directly or indirectly and which would require the use of an addressable system attached with the receiver set of a subscriber;
- (n) "Programme" means any television broadcast and includes -
  - (i) Exhibition of films, features, dramas, advertisements and serials
  - (ii) Any audio or visual or audio-visual live programme or presentation and the expression "programming service" shall be construed accordingly;
- (o) "Service Provider" means the Government as service provider and includes a licensee as well as any broadcaster, multi system operator (MSO), cable operator or distributor of TV channels;
- (p) "Set Top Box" or "STB" means a device, which is connected to, or is part of a television and which allows a subscriber to receive in unencrypted/descrambled form subscribed pay and FTA channels through an addressable system;
- (q) "Standard Tariff Package" (STP) means a package of tariff as may be determined by the Authority for supply of a set top box to the subscriber by a service provider for receiving programme;
- (r) "Subscriber" means a person who receives the signal of a service provider at a place indicated by him to the service provider without further transmitting it to any other person;
- (s) "You" means the subscriber.

### 2. Provision of Service:

- 1 Sreedevi Digital Systems Pvt. Ltd. cable service shall be made available to the subscriber with effect from the date of activation of the STB and on terms and conditions contained herein and also contained in the consumer charter which the subscriber hereby unconditionally accepts and undertakes to abide.
- 2 The subscriber shall fill in the Subscription Form (SF) in duplicate and submit the SF to the LCO. The subscriber shall ensure that the information stated in the Subscription Form (SF) is and shall continue to be complete and accurate in all respects and the subscriber hereby undertakes to immediately notify SDS or its LCO of any change thereto. Photo identification and Address proof has also to be submitted along with the SF, else the same will be treated as an incomplete SF. The LCO shall return the duplicate copy of the SF to the subscriber duly acknowledged.
- 3 All incomplete Subscription Forms shall be rejected and the deficiencies shall be informed to the subscriber.
- 4 The LCO will respond within 2 working days of receipt of application, and inform the subscriber of the deficiencies and shortcomings in the SF submitted by him.
- 5 The minimum period of subscription for pay channel(s) bouquet(s) / service(s) for the subscriber will be one month and the subscriber having opted for any pay channel(s) bouquet(s) / service(s) during for the period.
- 6 SDS shall have the sole and exclusive right to upgrade / replace or otherwise deal with the Set Top Box (STB) as may be deemed fit.
- 7 The total price of each STB is Rs.2100 and the STB is issued to the subscriber against a one time activation fee. The subscriber is entitled to usage of the STB and the ownership of the same shall remain with SDS.
- 8 SDS directly or through its authorized representative shall always be entitled to physically check and/or inspect the STB at any point of time without any objection or hindrance from the subscriber in any manner whatsoever. Unhindered access has to be provided for online and offline upgradation required from time to time.
9. The subscriber shall always be on his/her guards to ensure that no damage or harm or tampering is caused to the STB in any manner what so ever.
10. In case the subscriber tampers/alters the Viewing Card and STB for any reason whatsoever, the Subscriber is liable to make good the losses incurred on account of damages to STB. The same can be to the tune of the total actual cost of the STB.

11. The subscriber shall in no way be ever entitled to shift the STB without obtaining prior written permission from SDS. STB(s) are to be installed in the address as mentioned or disclosed in the form.
12. The STB allotted to the subscriber shall under no circumstances, whatsoever, be put to any other use or service other than for the purpose for which it is offered to the subscribers) by SDS. Any departure to the clause will entail subscribers) to a breach of agreement and will attract penalty as per applicable law.
13. The subscriber shall not assign or transfer any of his/her right to any other individual without prior written consent from SDS
14. That the STB as well as other hardware embedded inside the STB may malfunction because of mishandling, improper manoeuvring, sudden surge/fluctuation of voltage, dust, heat strong electromagnetic flux and/or other reasons. SDS shall not be held liable or responsible for the same in any manner whatsoever.
15. Information provided by the subscriber in this Form shall continue to be accurate in all material respects till the duration of provision of services by SDS and any changes thereto shall be informed by the subscriber immediately.
16. The subscriber has to give 15 days prior Notice to SDS, in the event he seeks disconnection of services.
17. All applicable taxes & duties as and when applicable (including charges if any) to be borne by the Subscribers.
18. Billing will be on a calendar month basis, and any billing disputes will be resolved within 7 days.
19. Interest on delayed payment will be charged @ 12% per annum.
20. SDS reserves the right to suspend/deactivate services to the subscriber after following due legal procedures in the event of,
  - a. the subscriber defaulting on account of his bill payment and/or.
  - b. the subscriber involving in acts of piracy fraud/mis use and/or
  - c. the subscriber being declared bankrupt/insolvent and / or
  - d. SDS being instructed by Government or any other competent authority and/or
  - e. SDS being mandated by any applicable law/s and or
  - f. the subscriber breaches any of the terms and conditions as laid down in this form; and or
  - g. the subscriber providing wrong information in this form and / or
  - h. Any force majeure event
21. MSO/LCO shall not be responsible for disruption of services during service maintenance period.
22. The Subscriber will indemnify and held harmless the LCO, MSO, SDS and its Affiliates from all loss, claims, demands, suits, proceedings, damages, costs, expenses.
23. The subscriber shall not hold SDS responsible for (i) any damage to property or person during installation and/or maintenance at his/her premises, (ii) any consequential or indirect damage or loss in relation to the service, (iii) if the service is suspended due to force majeure event, (iv) deactivation/suspension in lieu of protection of the intellectual property rights of any third party and/or to check other unlawful activities in relation to the service, even if such information (including information provided by any 3rd party) is later found to be correct, (v) technical issues arising from force majeure events including but not restricted to physical obstructions, geographic weather conditions and other causes of electronic/electrical interference or faults in other telecommunication networks or availability of poles and SDS shall not be liable for any consequences arising thereof including but not limited to damage to the Subscriber's television or devices of any type connected to it or any other property.
24. The subscriber shall ensure that SDS STB(s) / VC(s) are not tampered or misused: neither should any seal, brand, logo, information, etc., which affects or may affect the integrity/functionality identity for the SDS STB(s) / VC(s) be tampered/mis used/removed, nor shall tire subscriber use any decoding, receiving, recording device other than one television set before or after the SDS STB(s) / VC(s).
25. The date of activation of SDS STB(s) / VC(s) shall be deemed as the commencement date of Services.
26. In the event of the subscriber requesting suspension of services, SDS shall give effect to such request, provided, (i) the period of suspension sought by the subscriber is not less than one calendar month, (ii) the period of suspension sought by the subscriber is not more than 3 calendar months; and (iii) the period of suspension sought by the subscriber is in multiple of calendar months.
27. The subscriber can choose scheme introduced by SDS from time to time, only as per terms and conditions slated by SDS
28. The terms & conditions are subject to change in the event of any further recommendation and/ or guidelines provided by TRAI and/or MIB in future.
29. The subscriber represents / warrants / agrees and undertakes that
  - a. the subscriber is competent under law to execute this form
  - b. the subscriber shall use the services only for self-use and only at the installation address as given in this form and shall not use the service for any commercial benefit, including but not limit to relaying, re-transmitting or redistributing the services to third party or commercial customers.
  - c. the subscriber shall fully comply with applicable laws of the land
  - d. SDS shall have exclusive ownership of the STBs at all times.
  - e. the subscriber shall not shift the STB from the location address as mentioned in his form without prior intimation to and written permission from SDS.
  - f. the subscriber shall not assign any of his/her rights to any other individual
30. No failure to exercise and no delay in exercising any right, power or remedy under this Form by SDS shall operate as a waiver. Not will any single or partial exercise of any right, power or remedy preclude any other or further exercise of that or any other right, power or remedy.
31. The terms and conditions shall be construed and enforced in accordance with the laws of India and in no way such obligation vi dates any prevailing rule/law and regulation. All disputes settlements under the Telecom Dispute Settlement and Appellate Tribunal (TDSAT)
32. If any of the provision of the Terms becomes or is declared illegal, invalid or unenforceable for any reason, the other provisions shall remain in full force and effect and no failure or delay to exercise any right or remedy hereunder shall be construed or operate as a waiver thereof. Terms may be amended by the Authority from time to time and shall be binding on all.

### 3. Jurisdiction :

All disputes and differences with respect to these Terms between the Subscriber and SDS shall be within the jurisdiction of courts at visakhapatnam.
